Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school shall be restricted to 10. Further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by elaw subject to availability of class rooms of greater than 500 sq ft dimension.
2	The school is required to develop its website and maintain the mandatory public disclosure as per annexure - IX in the home page under distinct icon is not maintained as per circular no. 09 dated 21-05-2021 within 03 months and submit the link in the compliance.
3	The height of the boundary wall is less than 6 ft at some places. Thus, the school is directed to raise the height of the boundary wall and ensure that it should be bounded by concrete boundary wall from all sides with minimum 6 ft of height and submit the videography link covering the boundary wall from all sides in continuity along with aerial view within 03 months on SARAS Portal.
4	The school is required to develop its playground with sufficient outdoor game facilities (permanent court) as per Board's SoP within 03 months and submit the compliance.
5	The school has constructed a ramp to access the upper floors, but it is very steep and does not seem to be navigable by a wheelchair-bound student/staff. The ramp built seems to be weak ,of thin metallic sheet and with steep slope seemingly unsafe for

	students, it is appearing to be overlaid over a stair case. Thus, the school is directed to dismantle the same and re-construct the ramp to access upper floors with proper incline and safety features or install the lift with the provisions laid down in RPWD Act-2016 and Board's guidelines within 03 months and submit the compliance.
6	The school is required to construct the separate toilets for CWSN, boys and girls on every floor with sufficient space for easy movement of wheelchair and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and Board's guidelines, within 03 months and submit the compliance.
7	The composite science lab is temporarily made on the tables. There are no permanent fixtures, washbasin, water and gas connection in the workstation, proper storage and seating arrangement and No safety feature such as exhaust fan, fire extinguisher are available in the same. Thus, the school is required to upgrade the same with above facilities and as per Board's SoP within 03 months and submit the compliance
8	The mathematics lab is temporarily arranged without proper storage and seating arrangement. Thus, the school is required to upgrade the same as per Board's SoP within 03 months and submit the compliance
9	The school is required to procure more books and make the separate reading space for staff in the library and submit copy of involve of newly procured books and videography link covering the entire view of the library in the compliance within 03 months.
10	The computer lab has open wiring which is not safe for the students as wires are passing underneath student's chairs. Thus, the school is required to cover the same and submit the videographic evidence in the compliance within 03 months.
11	The school shall conduct training of its teachers with CoE Prayagraj within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6.
